

COALFIRE SOFTWARE END USER LICENSE AGREEMENT

COALFIRE SYSTEMS, INC. AND ITS AFFILIATES (“COALFIRE”) ARE WILLING TO LICENSE THE SOFTWARE TO YOU AS THE INDIVIDUAL, THE COMPANY, OR THE LEGAL ENTITY THAT WILL BE USING THE SOFTWARE (REFERRED TO AS “YOU” OR “YOUR”) ONLY ON THE CONDITION THAT YOU ACCEPT ALL OF THE TERMS AND CONDITIONS OF THIS COALFIRE SOFTWARE LICENSE AGREEMENT, ANY AMENDMENTS OR ADDENDA (COLLECTIVELY, THE “LICENSE AGREEMENT”). READ THE LICENSE AGREEMENT CAREFULLY BEFORE USING THE SOFTWARE. THIS IS A LEGAL AND ENFORCEABLE CONTRACT BETWEEN YOU AND COALFIRE. BY DOWNLOADING, INSTALLING, COPYING, CLICKING THE “I AGREE” OR “YES” BUTTON, OR OTHERWISE INDICATING ASSENT ELECTRONICALLY, OR USING THE SOFTWARE, YOU AGREE TO THE TERMS AND CONDITIONS OF THE LICENSE AGREEMENT. IF YOU DO NOT AGREE TO THE LICENSE AGREEMENT, CLICK THE “I DO NOT AGREE” OR “NO” BUTTON OR OTHERWISE INDICATE REFUSAL AND CEASE ANY AND ALL USE OF THE SOFTWARE.

1. DEFINITIONS. Unless otherwise defined in this License Agreement, capitalized terms will have the meaning given below.

“Affiliate” means an entity controlled by, under common control with, or controlling a party, where control is denoted by having (directly or indirectly) more than fifty percent (50%) of the voting power (or equivalent) of the applicable entity.

“Content Updates” means content provided by Coalfire for use with the Software intended to update, including, but not limited to, data, signatures, definitions, rules, policies, and URLs used by the Software, and may include content produced as a result of Your use of the Software.

“Disabling Code” means computer instructions that alter, destroy, shut down, or inhibit the Software and/or Your processing environment, including but not limited to other programs’ data storage and computer libraries, programs that self-replicate without manual intervention, instructions programmed to activate at a predetermined time upon a specified event, programs that permit unauthorized access to the Software or other software or hardware, and/or programs purporting to do a meaningful function but designed for a different function or programs that perform no function other than to utilize substantial computer, telecommunications, or memory resources, including without limitation viruses, Trojan horses, time bombs, protect codes, data destruction keys, trap doors, and similar codes or devices. Pop-up windows that notify You of restrictions or other requirements, but that do not prevent or inhibit authorized Use of the Software under this Agreement are not considered Disabling Code. It is agreed that this definition does not include screen lock-out features for: (i) unauthorized use of the Software, including use of the Software after any expiration or termination of this Agreement or any breach of this Agreement by Customer; (ii) Applications or installations in excess of the number of authorized Applications or installations licensed under this Agreement and through the applicable order form(s); (iii) Use of an unauthorized copy of the Software; or (iv) unauthorized modifications of the Software, provided that such screen lock-out features do not prevent or inhibit Use of the Software as authorized in this Agreement.

“Documentation” means the user documentation, user manual, and release notes provided for the Software. Documentation may be delivered in a text file, printed form, or published on a product Internet page.

“Maintenance” means the Coalfire maintenance option that You have purchased for the Software which may include Updates/Upgrades, Content Updates, and Technical Support. The Maintenance option You purchase determines Your entitlement to Updates/Upgrades, Content Updates, and/or Technical Support.

“Order Confirmation” means an electronic receipt, issued by Coalfire or a Coalfire Affiliate or partner, confirming the Software title, version, quantity (based on meter and model), and Maintenance that You have acquired.

“Personal Data” means the personal data as defined by applicable privacy or data protection legislation and in particular the EU Data Protection Legislation, provided by You or collected, processed, retained, disclosed, or used by Coalfire in connection with Your purchase and use of the Software and Maintenance. The term **“EU Data Protection Legislation”** means the: (i) General Data Protection Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (“GDPR”); and (ii) to the extent applicable to the Software and Maintenance, any other EU or EU Member State data protection laws with respect to the processing of Personal Data under this License Agreement.

“Software” means the Coalfire software program, in object code form, accompanied by this License Agreement, including any Updates/Upgrades and applicable Documentation.

“Technical Support” includes, but is not limited to, any telephone, online, or knowledge base support provided to You by Coalfire or a Coalfire authorized partner.

“Updates/Upgrades” means any generally available update to the Software, including, but not limited to, an enhancement, fix or patch, Version Upgrades, and Content Updates delivered as part of Maintenance. **“Version Upgrade”** means any generally available version of the Software that replaces the prior version of the Software pursuant to Coalfire’s then-current version upgrade policies and included with Your Maintenance option.

“Use” means to activate the processing capabilities of the Software, or to load, install, configure, execute, access, or employ the Software, or display information using the processing capabilities of the Software.

2. TERM; TERMINATION. The term of the software licenses granted under this Agreement shall be either perpetual or term-limited (“Subscription License”) as indicated on the Order Confirmation. Maintenance is only for the term indicated on the Order Confirmation. Under a Subscription License Your rights to use such Software and any access to Maintenance shall end on the date indicated on the applicable Order Confirmation and You shall cease use of the Software and access to Maintenance at the end of that term. However, this License Agreement and access to Maintenance shall terminate immediately without notice upon Your breach of any material term of this License Agreement. Upon any expiration or termination, You shall immediately stop using and uninstall or destroy all copies of the Software.

3. OWNERSHIP/TITLE. Coalfire and/or its licensors retain any and all rights, title and interest in and to the Software and any related copies, including all related intellectual property rights. Your rights to the Software shall be limited to those expressly granted in this License Agreement. All rights not expressly granted to You are retained by Coalfire and/or its licensors.

4. OPEN SOURCE SOFTWARE. The Software may contain open source components that are made available under applicable open source licenses agreements. This License Agreement does not alter any rights or obligations You may have under the applicable open source licenses and the disclaimer of warranties and the limitation of liability provisions in this

License Agreement shall apply to such open source components. Inquiries regarding open source components in the Software, including source code requests pursuant to the applicable open source licenses, must be directed to legal@coalfore.com.

5. LICENSE GRANT. Subject to Your compliance with this License Agreement, Coalfire grants to You, a non-exclusive, non-transferable, non-sublicensable, revocable, limited right to Use (and to allow Your Affiliates and third party consultants the right to Use) the Software (i) solely in support of Your internal business operations and solely at the authorized quantity; (ii) a reasonable number of copies for internal testing and interoperability activities, and (iii) to make a single archival copy of the Software for disaster-recovery purposes. You are responsibility for all actions, including those of your Affiliates and third party consultants, in connection with such Use. Certain Software may require registration in order to activate the Software. If You fail to complete the registration requirements, the Software features may become inoperable and You may be unable to use such features until You have completed registration. Certain Software may be subject to certain activation keys, passwords, or other protections issued or controlled by Coalfire. You may not disable, tamper with, or seek to circumvent any such protections. In addition to any other remedy that may be available, Coalfire shall have the right to suspend or prevent Your access to and Use of the Software if You breach the terms of this License Agreement. The Software may be subject to additional Use terms, which are defined in this License Agreement, and include, but area not limited to, the use meter and model for the Software, operating system requirements, and/or Use restrictions.

6. THIRD PARTY HOSTING. You may permit a third party host the Software on Your behalf, provided that such third party complies with this License Agreement and You remain directly liable to Coalfire for any act or omission by that third party as though such act or omission were performed by You.

7. THIRD PARTY PRODUCTS. You acknowledge and agree that Use of the Software requires recommended hardware, database, and application server as published in the Documentation. Any recommended third party product is not a part of this License Agreement. You are solely responsible for your procurement, choice, and use of third party product. Coalfire will not provide Technical Support for Use with third party products that are not recommended in the Documentation.

8. LICENSE RESTRICTIONS. You may not, either directly or indirectly, do any of the following: (i) Use, reproduce, publish, distribute, modify, rent, lease, sublease, sublicense, assign or transfer the Software except as expressly provided in this License Agreement; (ii) Create any modifications or derivative works of the Software; (iii) Reverse-engineer, disassemble, or attempt to derive the source code of the Software; (iv) Decompile the Software except and only to the extent described below; (v) Modify, block, circumvent, or interfere with any authentication, license key, or security measures in the Software; (vi) Use the Software on behalf of a third party such as for a service bureau, facility management, timeshare, or service provider; or (vii) Use a later version of the Software other than the version governed by this License Agreement unless You have separately acquired the right to use such later version and received an Order Confirmation. If the Software is embedded, incorporated, or loaded onto a hardware appliance when delivered or made available for download to designated hardware, then the license is restricted to use solely on that hardware. As an exception to the restrictions in Section 8 (iv) above, You may decompile the Software only when expressly permitted by law and when essential to achieve

interoperability of the Software with another software program, provided You have first asked Coalfire to provide the information necessary to achieve such interoperability and Coalfire has not reasonably made such information available. You may not disclose to a third party any information supplied by Coalfire or obtained by You as a result of decompilation or use any such information to create software that is substantially similar to the Software. Requests for such information should be directed to support@coalfire.com.

9. MAINTENANCE; TECHNICAL SUPPORT. Coalfire has no obligation under this License Agreement to offer a Maintenance option for the Software.

9.1 Maintenance and Renewals. Maintenance is made available only for the specific Software, for the quantity, and Maintenance term stated in the applicable Order Confirmation. You must acquire the same Maintenance option for the aggregate quantity of the corresponding Software title. Maintenance purchased for a certain Software title, may not be used for a different Software title. Maintenance must be continuous and renewed before the end of the current term, otherwise, to acquire current Maintenance, You will be required to pay the applicable fees from the end of the most recent valid term to the start date of the new term and You may be subject to additional costs in accordance with Coalfire's policies, such as administrative and reinstatement costs. Maintenance must be purchased and renewed for the aggregate quantity for the Software as indicated in all applicable Order Confirmations. You must submit to Coalfire Customer Care, in writing, any request for a reduction in any Maintenance renewal quantity. You may be permitted, in Coalfire's or its Affiliates sole discretion, to order Maintenance or renewal Maintenance at a quantity less than the aggregate quantity for the Software. To renew Maintenance for any Software for which the aggregate renewal requirement was previously waived, You may be required to pay Maintenance fees to cover the waived period before You may purchase current Maintenance. Any use of Maintenance without a valid Order Confirmation is deemed a breach of this License Agreement. Any Maintenance option purchased for the Software is subject to then-current published Maintenance and renewal, and end-of-life policies, published at <https://www.coalfire.com>, or successor URL.

9.2 Content Update Rights and Restrictions. You are granted the right to receive and use Content Updates as and when they are made generally available, for the Maintenance term, and only for the quantity, indicated on the applicable Order Confirmation(s). This License Agreement does not otherwise give You the right to obtain or use Content Updates, and any unauthorized access to or use of Content Updates is deemed a breach of this License Agreement. Upon expiration or termination of the Maintenance Term, You must uninstall any Software component that facilitates the receipt of Content Updates and use of Content Updates after expiration or termination of the Maintenance term is a material breach of this License Agreement.

9.3 Software Updates/Upgrades Rights and Restrictions. Software Updates/Upgrades may only be obtained for the quantity indicated in the applicable Order Confirmation(s). Any Software Updates/Upgrades to an existing license do not modify or alter Your authorized quantity. If You are permitted to transfer your licenses to a different Software title, then You may receive a new Order Confirmation on the condition that You cease using the replaced Software prior to use of such replacement Software. Software Updates/Upgrades are subject to the then-current version of this License Agreement.

9.4 Technical Support. During any term for which you have purchased Technical Support with the Software, Technical Support will be performed in accordance with the published terms and conditions and technical support policies published at: www.coalfire.com/agreements/techsupport, or successor URL.

9.5 **Disabling Code.** Coalfire represents and warrants that it has taken reasonable steps to test the Software licensed pursuant to this Agreement for Disabling Code and the Software is free from Disabling Code as of the date of delivery to You, including versions delivered as part of Maintenance.

10. LIMITED WARRANTY. Subject to Your compliance with the terms of this License Agreement, Coalfire warrants that the Software, as delivered by Coalfire, and when used in accordance with the Documentation, will substantially conform to the Documentation for a period of ninety (90) days from delivery. If the Software does not comply with this warranty and such non-compliance is reported in writing by You to Coalfire within the ninety (90) day warranty period, Coalfire will arrange for one of the following remedies, selected at Coalfire's sole reasonable discretion: (i) repair the Software, (ii) replace the Software with software of substantially the same functionality, or (iii) terminate this License Agreement and refund the relevant license fees paid for such non-compliant Software. The above warranty specifically excludes defects resulting from accident, abuse, unauthorized repair, modifications or enhancements, or misapplication. **THE FOREGOING IS YOUR SOLE AND EXCLUSIVE REMEDY FOR COALFIRE'S BREACH OF THIS WARRANTY.**

11. WARRANTY DISCLAIMERS. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THE WARRANTIES SET FORTH ABOVE ARE YOUR EXCLUSIVE WARRANTIES AND ARE IN LIEU OF ALL OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, SATISFACTORY QUALITY, FITNESS FOR A PARTICULAR PURPOSE, AND NONINFRINGEMENT OF INTELLECTUAL PROPERTY RIGHTS. COALFIRE MAKES NO WARRANTIES OR REPRESENTATIONS THAT THE SOFTWARE WILL MEET YOUR REQUIREMENTS OR THAT OPERATION OR USE OF THE SOFTWARE WILL BE UNINTERRUPTED OR ERROR-FREE. YOU MAY HAVE OTHER WARRANTY RIGHTS, WHICH MAY VARY FROM STATE TO STATE AND COUNTRY TO COUNTRY.

12. LIMITATION OF LIABILITY. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW AND REGARDLESS OF WHETHER ANY REMEDY SET FORTH IN THIS LICENSE AGREEMENT FAILS OF ITS ESSENTIAL PURPOSE, IN NO EVENT WILL COALFIRE OR ITS LICENSORS, RESELLERS, SUPPLIERS OR AGENTS BE LIABLE TO YOU FOR (i) ANY COSTS OF PROCUREMENT OF SUBSTITUTE OR REPLACEMENT GOODS AND SERVICES, LOSS OF PROFITS, LOSS OF USE, LOSS OF OR CORRUPTION TO DATA, BUSINESS INTERRUPTION, LOSS OF PRODUCTION, LOSS OF REVENUES, LOSS OF CONTRACTS, LOSS OF GOODWILL, OR ANTICIPATED SAVINGS OR WASTED MANAGEMENT AND STAFF TIME; OR (ii) ANY SPECIAL, CONSEQUENTIAL, PUNITIVE, INCIDENTAL OR INDIRECT DAMAGES WHETHER ARISING DIRECTLY OR INDIRECTLY OUT OF THIS LICENSE AGREEMENT, EVEN IF COALFIRE OR ITS LICENSORS, RESELLERS, SUPPLIERS OR AGENTS HAS BEEN ADVISED SUCH DAMAGES MIGHT OCCUR. IN NO CASE SHALL COALFIRE'S LIABILITY EXCEED THE FEES YOU PAID FOR THE SOFTWARE GIVING RISE TO THE CLAIM. NOTHING IN THIS LICENSE AGREEMENT SHALL OPERATE SO AS TO EXCLUDE OR LIMIT COALFIRE'S LIABILITY TO YOU FOR DEATH OR PERSONAL INJURY ARISING OUT OF NEGLIGENCE OR FOR ANY OTHER LIABILITY WHICH CANNOT BE EXCLUDED OR LIMITED BY LAW.

13. CONFIDENTIAL INFORMATION. “Confidential Information” means, for purposes of this License Agreement, the non-public information provided by a Party (“Discloser”) to the other Party (“Recipient”) related to the relationship between the Parties, provided that such information is: (a) identified or marked as confidential at the time of disclosure by the Discloser, or (b) if the initial disclosure is not in written or other tangible form, the Confidential Information will be so identified at the time of disclosure and reduced to written or other tangible form, appropriately marked and submitted by the Discloser to the Recipient as soon as reasonably practicable thereafter, but no later than thirty (30) days after disclosure. Confidential Information of Coalfire shall include product architecture, product research and development plans, non-public financial data and roadmaps, whether marked as confidential or not. The Recipient may use the Confidential Information that it receives from the Discloser solely for the purpose of performing activities contemplated under this License Agreement. For a period of five (5) years following the applicable date of disclosure of any Confidential Information, the Recipient will not disclose the Confidential Information to any third party. The Recipient will protect it by using the same degree of care, but no less than a reasonable degree of care, to prevent the unauthorized use, dissemination or publication as the Recipient uses to protect its own confidential information of a like nature. The Recipient may disclose the Confidential Information to its Affiliates, agents and subcontractors with a need to know in order to fulfill the purpose of this License Agreement, under a nondisclosure agreement at least as protective of the Discloser’s rights as this License Agreement. This Section imposes no obligation upon the Recipient with respect to Confidential Information which: (i) is or becomes public knowledge other than by breach of this License Agreement; (ii) was in the Recipient’s possession before receipt from the Discloser and was not subject to a duty of confidentiality; (iii) is rightfully received by the Recipient without any duty of confidentiality; (iv) is disclosed generally to a third party by the Discloser without a duty of confidentiality on the third party; or (v) is independently developed by the Recipient without use of the Confidential Information. The Recipient may disclose the Discloser’s Confidential Information as required by law or court order provided: (x) the Recipient promptly notifies the Discloser in writing of the requirement for disclosure, if legally permissible; and (y) discloses only as much of the Confidential Information as is required. Each Party will retain all right, title and interest to such Party’s Confidential Information. The Parties acknowledge that a violation by the Recipient of its obligations with respect to Confidential Information may cause irreparable harm to the Discloser for which a remedy at law would be inadequate. Therefore, in addition to any and all remedies available at law, the Discloser will be entitled to seek an injunction or other equitable remedies in all legal proceedings in the event of any threatened or actual violation of any or all of the provisions.

14. PROCESSING OF PERSONAL DATA. You acknowledge and agree that Coalfire will process Personal Data as part of the provision of the Software and Maintenance in accordance with, and for the purposes defined in the Coalfire Global Privacy Statement available at www.coalfire.com/privacy. To the extent that EU Data Protection Legislation applies to the processing activities involved in the provision of Software and Maintenance, the terms and definitions laid down in said EU Data Protection Legislation as well as in the Data Processing Addendum available at www.coalfire.com/privacy shall apply. As a Processor, Coalfire shall only process Personal Data on Your behalf in accordance with the terms of the Data Processing Addendum as mentioned above. “Aggregate/Anonymous Data” means: (i) data generated by aggregating Client data with other data so that results are non- personally identifiable, and (ii) learnings, logs and data obtained by Coalfire in connection with its provision of the Software. You agree that Coalfire may generate Aggregate/Anonymous Data, and notwithstanding anything to the contrary herein, the parties agree that Coalfire may use Aggregate/Anonymous Data derived from Client’s use of the Software (in a de-identified manner), including indicators of compromise, malware, anomalies, or other information that may be found as part of, or related to the performance of the Software for the purposes of gathering and compiling security event log data to look at trends and real or potential security threats,

improving and developing Coalfire's products and services, preparing and distributing statistical reports related to security trends and data patterns, internal research, and for providing general cybersecurity related services.

15. VERIFICATION. No more than one (1) time per calendar year, Coalfire may conduct a verification of Your records to confirm the quantity of Your use and compliance with license restrictions under this License Agreement. Upon thirty (30) days' written notice, You agree to provide Coalfire with information reasonably required to support this verification. Coalfire may review of Your records and analysis of data which Coalfire may collect, retain, process, disclose and use in connection with Your use of the Software. Reviews will be i) at Coalfire's expense, and ii) during Your normal business hours. Coalfire may engage a third-party to complete the verification. Neither Coalfire nor any third-party will require direct access Your computing systems. Coalfire will provide You with a verification report with details on any non-compliance and the corresponding purchase required to resolve any non-compliance. You agree to contact Your reseller or Coalfire within thirty (30) days of receipt of the verification report to receive a quote and complete the required purchase. Coalfire will require the order to include, as applicable, Software license fees, new and lapsed Maintenance fees, reinstatement costs, and interest. Lapsed Maintenance or excess subscription fees will be calculated at a minimum of one (1) year, unless an accurate deployment period can be determined. Interest is at the rate of one and one-half percent (1 1/2%) per month or the highest interest rate allowed by law, whichever is lower, from the date on which any amount became due. Previously agreed upon discounts will not apply to compliance orders.

16. SOFTWARE EVALUATION. If the Software is provided to You for evaluation purposes Section 5 (License Grant) is replaced with the following terms and conditions. Coalfire grants to You a non-exclusive, temporary, royalty-free, non-assignable license to use the Software solely for internal non-production evaluation subject to the applicable Use Rights Supplement. Such evaluation license shall terminate (i) on the end date of the pre-determined evaluation period or (ii) sixty (60) days from the date of Your initial installation of the Software, if no such evaluation period is pre-determined ("Evaluation Term"). You are solely responsible to take appropriate measures to back up Your system and take other measures to prevent any loss of files or data. The Software may contain an automatic disabling mechanism that prevents its use after a certain period of time. Upon expiration of the Evaluation Term, You must cease use of the Software and uninstall or destroy all copies of the Software. Coalfire shall accept no liability for Your use of the Software for evaluation purposes. All other terms and conditions of this License Agreement shall otherwise apply to Your evaluation of the Software. THE SOFTWARE MAY NOT BE TRANSFERRED AND IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND. THE SOFTWARE DOCUMENTATION IS PROVIDED FOR THE PURPOSE OF DESCRIBING THE SOFTWARE; COALFIRE DISCLAIMS ANY REPRESENTATIONS, WARRANTIES, OR OTHER COALFIRE COMMITMENTS, OBLIGATIONS, OR LIABILITIES, IN SUCH SOFTWARE DOCUMENTATION.

17. U.S. GOVERNMENT COMMERCIAL LICENSE RIGHTS. The Software and accompanying documentation is deemed to be "commercial computer software" and "commercial computer software documentation" respectively, as defined in DFARS Section 227-7202 and FAR 12.212 as applicable. Any use, modification, reproduction release, performance, display or disclosure of the Software by the U.S. Government shall be solely in accordance with the terms of this License Agreement, and except as otherwise explicitly stated in this License Agreement all provisions of this License Agreement shall apply to the U.S. Government.

- **18. CRITICAL APPLICATIONS.** The Software is not fault tolerant and use of the Software is not recommended for on-line control equipment in hazardous environments requiring fail-safe performance, such as the operation of aircraft navigation or aircraft communications systems, air traffic control, life-support systems, human implantation, nuclear facilities or systems, weapons systems, or any other application where failure of the Software could lead to death, personal injury, or severe physical or environmental damage. Any use contrary to this disclaimer is at Your own risk and Coalfire is not liable for such use.

19. EXPORT REGULATION. The export, re-export, or in-country transfer of the Software is subject to the export laws and regulations of the U.S. and other jurisdictions including, but not limited to, the U.S. Export Administration Regulations and European Union Council Regulations. The export or re-export of Software in violation of the foregoing laws and regulations is strictly prohibited. You agree that you will comply with all applicable export or import control laws and regulations and obtain appropriate U.S. and foreign governmental authorizations before exporting, re-exporting, importing, transferring or using the Software. The Software may be subject to import, distribution, transfer, or use restrictions for which You are solely responsible. The Software is prohibited for export or re-export to Cuba, Iran, North Korea, Iran, Syria, the Crimea Region of Ukraine and to any other country or region subject to trade sanctions. You shall not, directly or indirectly, facilitate giving a sanctioned country or entity access to the Software. You represent that You are neither located in, nor a resident or national of, any prohibited country or region, and that You are not a sanctioned person or entity named on a U.S. or other government list (including lists published by the U.S. Government, European Union, and United Nations). You may not export the Software in connection with the use or development of missiles or chemical, biological, and nuclear weapons. You may not export the Software to any military entity, or to any other entity for a military purpose, unless subject to a valid license. The following provisions of this License Agreement survive termination of this License Agreement: Definitions, License Restrictions and any other restrictions on use of intellectual property, Ownership/Title, Warranty Disclaimers, Limitation of Liability, Processing Personal Data, Confidential Information, U.S. Government Commercial License Rights, Export Regulation, Survival, and General.

21. GENERAL.

21.1. ASSIGNMENT. You may not assign the rights granted under this License Agreement, in whole or in part and whether by operation of contract, law or otherwise, without Coalfire's prior express written consent. Coalfire may assign this License Agreement to any party.
